

SYLLABUS

TITLE: Literary genres I: poetry and drama

CODE: ING 121

PREREQUISITE: N/A

CREDITS: 3 credits

DESCRIPTION

This course considers and analyses selected international poetry and drama. Students will participate through oral and written discussion of the works, examining them for their aesthetic, socio-cultural, and value-based stances.

JUSTIFICATION

Students are introduced to aesthetic reflections on everyday realities through these two genres. They learn to appreciate the literary artist's point of view as valuable new –and often different – perspective.

COMPETENCES

The course develops in the student the following competencies:

- Critical questioning
- Communication

OBJECTIVES

After completing the course, students will be able to:

1. Identify the test's cultural, social, and ethical environment and discuss how these elements contribute to the drama.

- 2. Recognize and discuss the role of symbolism, metaphor, imagery, and figurative language; identify pattern structure, metrics, and tone; identify soliloquy, monologue, aside, dialogue, and their dramatic purpose.
- 3. Identify and discuss ethical situations that arise in the work and compare and contrast these value systems (or lack thereof) with other literary texts presented during the course.
- 4. Incorporate pertinent individual and/or group research into class discussion and essay responses in analysis and close readings of the works.

METHODOLOGY

- Flipped classroom
- Conscious and analytical reading
- Writing exercises: a variety of texts including reviews and reflections.
- Connecting literary work with other artistic manifestations.
- Guest lectures
- Attendance at a play or poetry declamation.
