

SYLLABUS

TITLE: Literary Genres I: Poetry, Drama, and Essay

CODIFICATION: ESP 121

COURSE HOURS: 3 credits, 3 horse weekly, one semester

DESCRIPTION

Study of poems, dramas, and essays. Theoretical and technical aspects for textual comprehension are explained. The techniques and knowledge for poetry, drama, and essay analysis are also applied.

JUSTIFICATION

To study literature as an aesthetic creation and as a form of human expression is a valid way to explain and comprehend the human being's role in society. Through the critical analysis of theoretical and literary texts, students will relate themselves with the different world views and how to interpret them. Also, class readings and discussions will allow students to broaden their comprehension of language, to develop an understanding and respectful attitude towards diversity, and also a sense of engagement with a just, fair and peaceful society.

OBJECTIVES

At the end of these course, students will be able to:

- 1. Acknowledge the differences between fiction and non-fiction in Literature.
- 2. Identify the functions of literature.
- 3. Compare and contrast literary genres.
- 4. Identify the relationship between literature and other aesthetic and cultural expressions.
- 5. Distinguish the fundamental elements of poems, essays, and dramas.
- 6. Analyze and interpret poems, essays, and dramas.
- 7. Identify the ideological and human values according to the context of literary works.
- 8. Develop the value of tolerance and respect for differences by reading literary works.
- 9. Acknowledge and appreciate the aesthetical dimension of literary texts by reading them.
- 10. Promote reflection on ethical problems through reading and discussion of literary works.
