

SYLLABUS

TITLE: Self Leadership II

CODE: LID 301
PREREQUISITE: LID 101

CREDITS: 1 credit | 15 contact hours | 1 term

DESCRIPTION

This course offers students the opportunity to complete a series of micro-credentials in different topics to strengthen their professional and personal skills in the institutional learning management system (Canvas). Students must complete no less than 15 hours in micro-credentials. Students will receive a digital badge for each micro-credential completed.

JUSTIFICATION

Today's academic and professional context demands a complementary and constant education. According to the National Education Association (NEA), micro-credentials are a form of competency-based digital certification that can be issued to foster and document formal and informal professional learning experiences that help students and professionals acquire knowledge and improve their skills.

COMPETENCIES

The course develops the following competencies in students:

- Communication
- Research and exploration
- Critical questioning
- Entrepreneurship and innovation
- Ethical sense and social justice

OBJECTIVES

After completion of the course, students will be able to:

1. Identify knowledge and skills that can complement their academic training in a particular discipline.

- 2. Take responsibility for their complementary academic training in the university context.
- 3. Understand the importance of learning new skills throughout life.
- 4. Establish relationships between diverse types of knowledge and skills.

CONTENTS

The content of the short workshops must be aligned with the students' professional interests, in accordance with the thematic axes established by the academic units. Universidad del Sagrado Corazón will have a specific offer of workshops scheduled each semester. Students may also present evidence of having completed this type of experience at another institution. This other institution can be academic, business, non-profit or community based.

METHODOLOGY

The following strategies from the active learning methodology are recommended:

EVALUATION

Students must present evidence of having completed the equivalent of fifteen contact hours in short workshops. They can exceed the number of hours, but not less. In the case of students who choose to take workshops or conferences from Sagrado's offer, they must present the certification provided in the activity after signing the entry and exit.

In the case of those who choose to take workshops or conferences outside of Sagrado, they must present an official certificate or letter from the institution or the provider of the activity. The full name of the student, the name of the activity, the date and contact hours must appear on this evidence. All information provided as evidence must be verifiable.

The course evaluation will be **Approved (P)** and **Not Approved (NP)**.

LEARNING ASSESSMENT

The institutional assessment rubric is applied to the course's core activity.
