TITLE:	Construction of an Ideal Society
CODE:	GCC 201
PREREQUISITE:	GCC 101
CREDITS:	3 credits 45 contact hours 1 term

DESCRIPTION

This course will study how the different models of societies in the world have emerged and developed: imaginaries of the ideal society, religious crises, the Reformation and Counter-Reformation, the revolutions of the eighteenth century, the concept of political independence and its effect on Puerto Rico, and the revolutions, dictatorships, and the search for peace in Latin America in the twentieth century. It will examine the historical context and the various social effects of these models today and their literary, plastic, or musical references and representations.

JUSTIFICATION

This course promotes the comprehension of history and the critical vision necessary for students to understand and question the social configuration of their reality and to participate in the change and development of a more authentically Christian society, united in justice and peace.

COMPETENCIES

The course develops the following competencies in students:

- Critical questioning
- Communication

OBJECTIVES

After completion of the course, students will be able to:

1. Distinguish the imaginaries of the ideal society as elaborated by various thinkers.
2. Analyze theological approaches and their impact on society.
3. Reflect on the role of the individual in the construction of society.
4. Discuss different movements and their cultural, economic, and social effects.
5. Analyze current transformative social problems and proposals.
