### DESCRIPTION

The course examines the development of the social welfare system and social policy from a critical, historical, and inclusive perspective of human rights. The process of analysis, formulation, implementation, and evaluation of social policies is studied. This considers contemporary patterns of social service provision and their repercussions for socially and economically disadvantaged populations. It analyzes the existing debates and dilemmas of the role of professional social work practice in the development of affirmative policies and the ways to engage in these processes through practices that promote social justice, such as social action. The course is aimed at students of Social Work and related disciplines.

### JUSTIFICATION

Everyday life is intimately linked to social policy determinations, which have a direct impact on the sense of general well-being and on the forms of interaction between different social groups. The exercise of citizenship and professional practice committed to social innovation refers to the ethical responsibility to participate in and promote the creation or improvement of social policy measures to guarantee the fulfillment of human rights. Therefore, it is necessary to master the professional competencies that guarantee contributions that promote collective well-being and effective policy actions

## **OBJECTIVES**

After completion of the course, students will be able to:

1. Explain the concepts: social welfare, social justice, oppression, human rights, need, social problem, and social policy.
2. Interpret, from a historical-critical point of view, the development of social welfare and its system.
3. Outline the interconnectedness of social policy with historical, social, economic, organizational, environmental, and global processes and influences in Puerto Rico and the United States.
4. Explain how human rights and social justice, as well as social welfare and the services that support it, are influenced by existing economic and social policy.
5. Identify social policy alternatives for each area of social welfare, as well as the ways of accessing and providing social services existing in Puerto Rico.
6. Critically expose the processes for the formulation and analysis of social policies.
7. Recognize the civic-professional responsibility to participate in the development, creation, or improvement of social policy.
8. Critically analyze social welfare policies in Puerto Rico, in light of principles such as: equity, social, economic, and environmental justice, participation, and effectiveness.
9. Apply evidence from social research to improve social policy and service delivery.
10. Propose ideas in the policies analyzed that promote human rights and social, economic, and environmental justice.
11. Engage in practices that promote human rights and social, economic, and environmental justice.
