TITLE: Legal and Ethical Aspects of Communication

DESCRIPTION

This course is aimed at Communication students and introduces them to the study of legislation, jurisprudence, and regulations at the state and federal level that are applicable to the media and management for professionals within such communications media.

JUSTIFICATION

It is of vital importance that the professional communicator knows the legal doctrines that affect communication. Ignorance of the legal aspects of communication contributes to inefficiently committing the resources of employers, clients, and society in general. Communicators must also know the laws that apply to them as managers or employees in the social communication scenario.

1. Define concepts, vocabulary, and legal and political terminology applicable to mass media.

3. Discuss the different legal theories to interpret the right to freedom of expression.
4. Identify and explain the background, development, achievements, and limitations of the rights of expression in our society.
5. Identify and differentiate the legal doctrines, statutes, and government agencies that regulate mass media and other forms of communication.
6. Recognize and analyze the basic regulations governing advertisements, specifically misleading advertisements, and the reason why laws exist to control them.
7. Know the legal provisions on intellectual property protection and its applications.
